Meeting Minutes

November 15th, 2022

A regular meeting of the Board of Trustee (the "Board" or "BoT") of the Mott Hall Charter School (the "MHCS") was held on the above date beginning at 5:35 p.m. local time pursuant to notice duly given.

Attendance

- The following Trustees were present: Natalie Thompson, Sandra Lugo, Karen Bhatia (Video Conference), Francesca Weindling (Visual Conference), Kevin Murungi (Video Conference), Jason Caldwell (Video Conference)
- The following school staff participated: Connie Lobdell, Principal and Executive Director; Yvette Colon, Director of Operations (DOO)

Call to Order. Public Comment and Board Discussion

- After noting that a quorum was present, the meeting was called to order at 5:35 p.m.
- Parents present but no public with comments.
- Natalie Thompson:
 - o Review of prospective Board members
 - Move quickly to submit paperwork for prospective board members to the State
 - Prospective board members to be invited to future Board meetings no right to vote
 - o Josh Moreau to be notified and updated on personnel changes
 - o Extensis is working out well
 - Operation Exodus have not heard back from them; draft letter from attorney
- Connie Lobdell:
 - Instructional Audit Dr. Awosogba wants to be thorough and will be reporting
 - Scholars' performance above district numbers in general
 - o Literacy rate going up
 - o 6th grade is performing above the other grades
 - o Literacy RTI, Read 180 and small group instruction
 - o Developing intervention for math
 - o 7th grade teacher turnover
 - o Absences due to illness
 - o Connie Lobdell is teaching classes to make sure there is consistency in instruction
 - o SEL strong foundation
 - A lot of professional development in this area
 - Focus on SEL and not on remedial practices
 - Not waiting long to "pull the trigger"
 - o Mr. Ocasio Sports
 - \$4,250 for Sports Department (Grant: \$3,500 and DonorsChoose value of \$750)
 - o High school process going well
 - o Approximately 15 scholars in shelters
 - Home visits and observations have noticed scholars and families who have gone without eating and are struggling
 - Create food pantry
 - Farmer's market
 - Parent to Parent where parents will share
 - Natalie Thompson recommended getting in touch with Minerva Delgado regarding food distribution
 - Material Revision

- Waiting on the state to inform us who the new NYSED liaison is going to be
- Liaison needed specifically for prospective board members
- Concern is change in enrollment numbers
- Yvette Colon
 - Reviewed Accountability Dashboard
 - Enrollment and Recruitment
 - 6th grade 69; 7th grade 66; 8th grade 90: 225 scholars
 - 20 applications are in for next year (2023-2024)
 - o Scholars in need of coats
 - o Working on building relationship with parents/families where they feel comfortable to say and make school aware of their needs, i.e. coats
- Karen Bhatia
 - o Inquired about Randall's Island visit
 - Connie Lobdell informed that the shelter on Randall's Island was for men only and not families
- Natalie Thompson
 - Suggested the need to staff someone in the area of SEL, e.g. clinician
 - Holiday celebration on Friday, December 9th
 - Invite prospective board members
 - Gifts for staff members
