- o Next steps for instruction/lessons
- o Focus on areas of teaching/reteaching
- o Provides specific standardized responses
- o Intervention groups
- o Small group instruction
- Standards and sub standards
- o Luis Quan recommended LinkIt! tracker (<u>www.linkit.com</u>) which provides all data in one tracker (all in one place). Helps break down data better and at more granular level; practical and efficient.
