A regular meeting of the Board of Trustee (the "Board" or "BoT") of the Mott Hall Charter School (the "MHCS") was held on the above date beginning at 5:35 p.m. local time pursuant to notice duly given.

Attendance

- The following school staff and guests were present: Connie Lobdell, Principal and Executive Director.

Call to order, Public Comment and Board Discussion

- After noting that a quorum was present, the meeting was called to order at 5:35 p.m.

- Motion was made for approval of May 20th, 2025, minutes
 - o Minutes were reviewed and approved
- Board Retreat
 - o Tentatively scheduled for June 24th, 2025
 - o Location: Marriott Hutchinson Metro Center, Bronx, NY
- Student Data
 - o 4% gap in ELA compared to district averages
 - o 10% gap in Math compared to district averages
- Renewal Action Plan
 - Share draft renewal action plan with board members prior to retreat
 - o Provide information on the professional development plan
 - o Use of research-based practices
 - o Cycle of support for teachers and instructional leaders
- Summer Boost Program
 - o Ms. Melendez completed training in new accountability and assessment plan
 - o Will recruit 60 students
 - o Summer Boost Program provided an additional \$40,000, putting the budget over \$100,000
- <u>●</u> _8th grade Graduation
 - o Early end date was approved approximately four years ago and the State was aware
 - o Compliance with State instructional day requirements
 - o Clarify rationale and approval process for 8th grade students' early end date
- Incoming 6th Graders
 - o Ongoing communication throughout summer
 - o Last Parent to Parent meeting will be specifically for the incoming 6th graders and their families
 - o Incoming 6th grade students will begin before all 7th and 8th grade students
